Hello all, attached please find a memo from FAA discussing the effect of the Capital Access Coalition's proposal on delays at DCA. The key finding is that:

Based on Annual Service Volume (ASV) delay analysis, we find that an increase of 20 daily round trip operations would increase delay by 25.9%, and an increase of 25 daily round trip operations would increase delay by 33.2% at DCA.

(Before sending this memo, FAA sent me an email estimating much higher delay increases. These figures supersede those and are the ones we should use.)

I will be sharing this memo with Commerce and my contacts in the Youngkin admin. Our comms team placed it in Punchbowl this morning.
